

## 11 ADDITIONAL AGREEMENTS ON DETAIL AND REPORTING

The Monitoring Report proposes a range of monitoring provisions for the North Hoyle Offshore Wind Farm. In addition to the proposals made confirmation and agreement is required with the Licensing Authority or their agents. The following outlines some aspects of detail, which require further agreement that can only be achieved with two-way dialogue.

### 11.1 MARINE FISH

Construction was completed by end of March 2004. Full proposals for fish surveys have been provided to the licensing authority; as per Section 9.7 of the Schedule to Licence No 31579/05/0 (as amended). Further site specific trawl surveys are not currently proposed but may be undertaken post construction pending consultation with CEFAS and CCW.

### 11.2 ORNITHOLOGICAL MONITORING

#### 11.2.1 Objective 1

Agreement with CCW as agent to the Licensing Authority on optimal survey design analysis methods by the end of December 2004.

Reporting on the first year of post-construction data to the end of March 2005 will be presented in the annual FEPA report in July 2005.

#### 11.2.2 Objective 2

Agreement with CCW, as agent to the Licensing Authority, on analysis methods by the end of March 2005.

#### 11.2.3 Objective 3

Agreement on methods and the threshold of change will be sought with CCW, as agent to the Licensing Authority, by the end of March 2004.

#### 11.2.4 Objective 4

Agreement on analysis methods and magnitude of population change that will trigger this Objective will be sought with CCW, as agent to the Licensing Authority, by the end of March 2005.

The identification of the need for benthic sampling will, subject to acquisition of aerial survey data for January 2004 in an appropriate form and timescale from the CCW Common Scoter Project, by the end of March 2004.

#### 11.2.5 Objective 5

There are no deadlines for this Objective for 2004 or subsequent years.
